Maxxsonics USA, Inc. is pleased that you have purchased MB Quart, Autotek, Crunch, Hifonics and MAXXLINK products.

As the manufacturer of MB Quart, Autotek, Crunch, Hifonics and MAXXLINK car audio products, Maxxsonics USA Inc. Warrants to the original consumer purchaser the product to be free from defects in material and workmanship for 12 months from date of purchase.

All other parts and accessories of the system are warranted to be free from defects in material and workmanship for 12 months from date of purchase. Maxxsonics will repair or replace at it's option and free of charge during the warranty period, any system component that proves defective in materials and workmanship under normal installation, use and service, provided that the product is returned to the authorized Maxxsonics dealer from where it was purchased to ensure that the problem you are experiencing is not related to the installation or misuse of the product.

When contacting Maxxsonics USA, Inc. for warranty we will need the following to process your request

- You must provide suitable proof of purchase of the product. This includes a copy of the original receipt showing a purchase date
- Store name and location
- Item purchased
- Valid serial number

### What is not covered under warranty?

Any damage to the product as a result of misuse, abuse, accident, incorrect wiring, improper installation, alteration of date code or bar code labels/ serial number, revolution, fire, earthquake, flood, stolen or any sneaky stuff because someone messed up, repair or alteration outside of our factory or authorized service centers and any thing else you have done that you should not have done is not covered.
